1. Bidders may obtain further information and inspect the Bidding Documents at the Office of Suryabinayak Municipality; Katunje, Bhaktapur. Only eligible fabricators with the key qualifications as mentioned in the Bidding Document should participate in this bidding.
2. Bidding Documents can be purchased from the Suryabinayak Municipality; Katunje, Bhaktapur upon submission of a written application, along with duly attested copies of Bidder's registration, VAT registration all valid for Fiscal Year 2076/077 and upon payment of a non-refundable fee as indicated in the table above till the last date and time for bid purchase mentioned above. Bidder's representative who wishes to purchase the Bid Documents shall furnish Identity letter issued by the authorized person of the firm or JV firms.
3. Pre-bid meeting shall be held at Suryabinayak Municipality; Katunje, Bhaktapur at 13:00 hrs on **2077/06/25**.
4. Sealed bids must be submitted to the office of Suryabinayak Municipality; Katunje, Bhaktapur on or before the *last date and time for bid submission* mentioned above. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend on the date and time for bid opening mentioned above at the office of Suryabinayak Municipality; Bhaktapur. Bids must be valid for a period of *Bid Validity Period (days)* indicated in table above from the date of bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid or cash deposit voucher in **Deposit Account No.Ga-3-01903000003000000002 Nepal Bank Limited, Kamalbinayak, Bhaktapur**.
6. Bid security in the form of bank guarantee shall resemble with the format provided in bidding document and must be un-conditional. The bid security which do not resemble with the specified format or which are conditional shall be considered void.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Bidders are advised to visit the construction site and assess the actual site conditions before submitting their Bids.
9. All the rights as to whether to accept or reject the bid partially or fully are reserved to Suryabinayak Municipality; Katunje, Bhaktapur.
10. Any amendment to the tender notice shall be published in notice board of Suryabinayak Municipality.
