1. ***Suryabinayak Municipality has allocated funds towards the Construction of Ward Office Building for Suryabinayak-05 Contract for SM/09/079/080-01.*** Bidding is open to all eligible as per Section V of bidding document.
2. ***Suryabinayak Municipality invites only electronic bids from eligible bidders for the construction of Construction of Ward Office Building for Ward No-05 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.***

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: ***[NRs 108 million]***
 - Minimum Work experience of similar size and nature: ***minimum one government funded rcc office building of minimum cost 16 million within the last 10 years with minimum 300 cu.m m20rcc works and 40 mt steel reinforcement works.***

6. Electronic bids must be submitted to the office ***Suryabinayak Municipality, Katunje, Bhaktapur*** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before ***12:00 PM, 2080.03.22*** Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at ***1:00PM*** at the office of ***Katunje, Bhaktapur.*** Bids must be valid for a period of ***120 days*** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of NRs.100,0000.00 (One million).
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
