Bidder's representative who wishes to purchase the Bid Documents shall furnish Identity letter issued by the authorized person of the firm or JV firms.
- 3. Pre-bid meeting shall be held at Suryabinayak Municipality; Katunje, Bhaktapur at 13:00 hrs on 2077/07/14.
- 4. Sealed bids must be submitted to the office of Suryabinayak Municipality; Katunje, Bhaktapur on or before the *last date and time for bid submission* mentioned above. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend on the date and time for bid opening mentioned above at the office of Suryabinayak Municipality; Bhaktapur. Bids must be valid for a period of *Bid Validity Period (days)* indicated in table above from the date of bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid or cash deposit voucher in Deposit Account No.Ga-3-01903000003000000002 Nepal Bank Limited, Kamalbinayak, Bhaktapur.
- 6. Bid security in the form of bank guarantee shall resemble with the format provided in bidding document and must be unconditional. The bid security which do not resemble with the specified format or which are conditional shall be considered void.
